

**FUTURE NOW ENERGY LLC (“Future Now  
Energy”) VARIABLE RATE PLAN  
TERMS AND CONDITIONS**

**KEY TERMS:**

Natural Gas Rate: 67.9 cents per therm for March 2025 (Nicor Gas price \$0.38/therm). You enter into the FNE Rebate program and can earn up to 10% of your gas charges as credits back on future bills (see program details below).

Site Administration Fee: \$6.99/month

Cancellation Fee: No cancellation fee

Term: Monthly

**THIS AGREEMENT**

We agree to supply natural gas to you and you agree to pay us for natural gas based on the terms and conditions of this Agreement. Future Now Energy is an independent seller of gas certified by the Illinois Commerce Commission and is not employed by, representing, endorsed by, or acting on behalf of Nicor Gas. Future Now Energy is not the same entity as your gas delivery company and you are not required to enroll with Future Now Energy. **PRICE AND TERM**

**Variable Natural Gas Rate.** You agree to a variable energy rate which may change from month to month. In determining our price, Future Now Energy considers daily average market prices together with changes in taxes, fees, and costs of operation.

**Rebate.** A rebate of 10% of your natural gas charge, excluding taxes and fees, will accrue during the Term. The Accrued Rebate is payable in two parts. A quarterly rebate of 5% becomes payable during the third quarter and every quarter thereafter. A lump-sum payment for the other 5% is payable during the 9<sup>th</sup> quarter of this contract. Rebate amounts less than \$100 will be carried forward to future quarters for payment. Rebate accruals will not be paid if the Agreement is canceled or terminated prior to the quarter in which the rebate becomes payable.

**Site Administration Fee.** A set amount we charge for the supply of energy on a per site per billing cycle basis. The administration fee is \$6.99 per month.

**Term.** You will receive a letter from Nicor Gas confirming the switch to Future Now Energy. From the date the utility sends the notice, you will have 10 business days before the switch will become effective. This Agreement will renew monthly thereafter until canceled or terminated (the “Term”). ## **BILLING AND PAYMENT**

**Billing.** Nicor Gas will bill you regularly, based on the most current contact information you have provided to them. The Nicor Gas bill will include Nicor Gas's distribution charges and a separate section labeled "Additional Products and Services" for Future Now Energy's natural gas charge and any other fees described in this Agreement.

**Late Payments.** If we do not receive your payment in full by the Payment Due Date indicated on your Nicor Gas bill, we may charge you a Late Payment Charge of 3.25% of any amount you owe to us that is not paid in the billing cycle following the billing cycle in which the amount was originally billed.

**Payment.** You must pay our portion of the Nicor Gas bill in full by the Payment Due Date. Payments on our behalf should be made directly to Nicor Gas.

## **TERMINATING THIS AGREEMENT**

**Your Termination Rights.** You may cancel this Agreement at any time. We will begin the de-enrollment process through Nicor Gas within 5 days of notification. You will be responsible for all natural gas charges and other fees up to and including your final bill. Nicor Gas will determine an estimated end date based on your regular billing cycle and the cancellation date and you will receive one final bill (typically within 20-30 days).

**Our Termination Rights.** We may terminate all or a portion of the Agreement without penalty: Immediately on notice to you if you do not fulfill any of your obligations under this Agreement; if you become insolvent; if Nicor Gas terminates your natural gas service; if you are not eligible to participate in Nicor Gas's Customer Select Program; if the Illinois Natural Gas Choice Program ends; or if Nicor Gas terminates its Customer Select Program.

## **OTHER TERMS**

Future Now Energy may assign this Agreement to another Illinois Commerce Commission ("ICC") certified Alternative Gas Supplier authorized to supply natural gas in the Nicor Gas service area of Illinois. You will receive no less than 30 days' notice prior to the assignment.

Future Now Energy makes no representations, guarantees, or warranties other than those expressly stated in this Agreement. Future Now Energy expressly disclaims any other promises, guarantees, warranties, expressed or implied by our third-party marketing representatives.
